




President's Report 2018

During the 2018-2019 school year, the St. James Scholarship Foundation continued to emphasize building awareness of our foundation, conducting donor research, and reviewing our organizational by-law.

Our by-law review resulted in revisions to our meeting requirements, a new direction on electronic decision making, and gender neutral language. The revised by-law will be presented for approval at our Annual General Meeting, May 9, 2019.

The history and current status of the Foundation was presented to the St. James-Assiniboia School Board of Trustees on October 9, 2018. This followed the civic election and was received as the Report on Education at the start of the meeting. One of our past award recipients, Vanessa McKay (featured on the following page), accompanied the President for this opportunity and spoke on behalf of students benefiting from our program.



The President has continued meeting with a group of Silver Heights Collegiate 1960's alumni. This group has become one of our most loyal and long term donors with a record of giving for more than ten years.

This year, the character of our donors changed significantly as we welcomed new corporate and institutional donors. St. James Burger & Chip Co. is our new corporate donor. The local eatery created a scholarship at both St. James Collegiate and Collège Sturgeon Heights Collegiate in the amount of \$500. Our institutional donor was the Patricia Chapter, Order of the Eastern Star. The Order of the Eastern Star donated \$10,000 to support the Anne Simpson Memorial Award at Westwood Collegiate. This award will be perpetual as we have established a sub-fund in our Agency Fund at the Winnipeg Foundation to provide the required income.

During the past year we experienced some changes in our Board of Director's membership. James Dunlop, CPA, CGA, the Accounting Supervisor in the Division has taken on the role of Secretary Treasurer. Lindsey Sawyer has retired and in her spot, we welcomed Deanne Crothers B.A.(Hons).

Our board appreciates the ongoing administrative support provided by the St. James-Assiniboia School Division, all without cost to the endowment. Staff members James Dunlop, Accounting Supervisor, Elizabeth Rothery, Executive Secretary, and Jennifer Cameron, Information Officer, deserve our thanks and appreciation for the direct support they provide to our board.

We look forward to continuing to serve our community as we work to recognize the many dedicated and capable young people attending our community schools. We welcome community contributions to our endowment fund, which directly supports deserving students in their future endeavours.

Vanessa is fulfilling her early promise by continuing to be recognized for academic achievement in her university studies. In the past two years, she has been presented with these awards:

"Awards and scholarships have allowed me to focus on academic work and less about money. Adding awards to my resume allows me to be recognized as a good candidate for future academic awards."

lot to students," said Vanessa. "Without this support, dreams do not become reality. I would not be where I am without them. It inspires one to reach goals that at first seemed impossible."

"Work hard and get involved with an interest you are passionate about. Get involved with extra-curricular activities and community service as having a broad experience is very important."

Even with her busy academic life, Vanessa still finds time to help. Donor Profile St. James Burgers & Chips Co.



Local business leads the way investing in community grads

The recently established burger joint on the corner of Ness Avenue and Collegiate Street weaves generousity into their business plan.

St. James Burgers & Chips Co. opened in October of 2017. Inside the building, once home to the Red Boot Drive Inn and Pop's Burgers, the new eatery serves up a variety of gourmet burgers, fat boys, fries and more. Best of all, the business is open all-year round.

"We are really happy and pumped to be here," shared co-owner Ravi Ramberran (pictured on the left). "The community is so strong and the support has been great."

St. James Burgers & Chips Co. is quickly making a name for themselves both in the community and across Winnipeg. To date, they've earned accolades such as 1st place in La Poutine Week 2018 and Virgin Radio's Best Fries in Winnipeg 2019. While the new business is flourishing, they are determined to bring more than great tasting eats into the community.

"We don't hire anyone unless they want to give back to the community," said Ravi. "If you don't have it in your blood than you aren't the right fit."

The business donates 25% of the tips they receive to help support local causes in the community. The staff team, made up of five members, works together to decide on where to donate the funds. They all take part in earning the tips and make sure everyone is on board deciding

which causes they help to support. With this system in place, the business has been able to donate more than \$12,000 to local charities since they opened, with a strong emphasis on helping veterans.

Co-owner Sanjay Sewpaul (right) brought the idea forward to create a scholarship opportunity for local youth. As a graduate of St. James Collegiate, he knew about the St. James Scholarship Foundation and thought it aligned well with the business's aim to make a difference in the local community. Through partnering with the Foundation, St. James Burgers & Chips Co. sponsored two new scholarships, each in the amount of \$500. The awards will be presented to deserving candidates at the two closest high schools - St. James Collegiate and College Sturgeon Heights Collegiate. The criteria for the scholarship is centred on citizenship, requiring the individual to be active in the community as well as to be a positive advocate for women's rights.

"We both have little girls," explained Ravi, referring also to Sanjay. "For this specific scholarship, we want to give to students who give back to the community, help others in need and who display some kind of equity role."

Both scholarships will be presented for the first time in June of 2019 at the corresponding schools graduation ceremonies.

Eric Jonasson Award

Honouring family and friends through scholarships

Stefan Jonasson's family has been part of the St. James community for seven generations.

"One set of my great-grandparents came to St. James in 1908 to operate a dairy farm in what is now St. James Industrial Park. They've had descendants living here ever since, although we don't keep dairy cattle any more."

Stefan attended Assiniboine School where his father planted trees in the school grounds in a personal campaign of guerrilla beautification. His dad was eventually "found out" by the school division and thanked for his efforts. From Assiniboine, Stefan went on to St. James Collegiate, where he had the good fortune to meet his wife, Cindy Nagamori. Throughout those years, the teachers in the Division nurtured his love of learning and inspired his confidence.

"I was fond of virtually every teacher I had and and some of them had a bigger impact on my life than they'll ever know. Forty years after leaving high school, I still quote things they said and remember examples they set."

He left St. James Collegiate one credit short of graduation, which led him to enrol at the University of Winnipeg Collegiate. At the Collegiate, he was able get his start on university while completing his high school. The plan was to study political science and then go to law school. During his first year, Stefan's father died and after the academic year was over, he left university to go to work. Five years later, he returned to university part-time, studying anthropology, history, and religious studies, earning his BA in religious studies. He won the university gold medal in his discipline.

He continued his studies in comparative religion in the joint masters program through the universities of Winnipeg and Manitoba. Stefan settled into the Master of Divinity program at the University of Winnipeg, graduating with the Governor General's Gold Medal – the only Canadian to win this honour for a theological degree. Throughout his studies, he earned several scholarships, which boosted his confidence and helped to defray the costs of his education.

"It's impossible to overestimate the importance of scholarships," he says, "not only for the financial aid they offer, but also for the inspiration they give to students, encouraging them to excel in their studies."

An ordained Unitarian Universalist minister, Stefan was tapped by his denomination to serve in three successive executive positions. In 1991, he was named District Executive for Western Canada by the Unitarian Universalist Association, overseeing the denomination's activities in the prairie provinces and northwestern Ontario. Eight years later, Stefan became Director for Large Congregations by the Boston-based denomination and his responsibilities became continent-wide. He built the program from the ground up, providing developmental services that recognized the complexity and unique needs of large congregations. He emerged as the denomination's acknowledged expert on



congregational governance, organizational development, and personnel management. The work meant he travelled often to speak at conferences and work directly with congregational leaders. He spent his last four years at the UUA as Director of Growth Strategies.

Back home in Winnipeg, he spent as much time volunteering as his heavy travel schedule allowed. Stefan was involved in the U of W Alumni Association, eventually becoming its president, and now serves on the Board of Regents. Since the beginning of 2015, Stefan has been the editor of Lögberg-Heimskringla, a newspaper serving the Icelandic Canadian and Icelandic American communities since 1886. In fact, it is the oldest ethnic publication in Canada.

"It takes a lot of work to produce a high-quality periodical with a small staff, but it's deeply satisfying to see the end result every two weeks," Stefan says. "Who could have imagined my work on the Jimmies' Journal at St. James Collegiate forty years ago would prove to be so useful to me now? The technology and techniques have changed since then, but the human instincts and input are pretty much the same – not to mention the pressures of meeting a deadline."

Stefan made his first contribution to the St. James Scholarship Foundation 20 years ago. Following the untimely death of his oldest brother, Eric, who had been a school trustee in St. James-Assiniboia, a bursary was established in his brother's name.

"It's important to me that this scholarship continue to be funded – both to honour my brother and to support the young people of our community who, with a little encouragement, might pursue higher education in pursuit of the their dreams," Stefan says. "Being a community means investing in one another, helping one another, and recognizing one another's accomplishments. Scholarships help to level the playing field while encouraging excellence. And they can allow us to honour family and friends while investing in the next generation."

Anne Simpson Memorial Scholarship

Leaving behind a legacy to support youth in the community

Originally from Scotland, Anne Simpson spent most of her life living in the community of Westwood. A vivacious woman with a true zest for life, her spirit is sure to be remembered in the area she called home for many years to come.

When Anne Simpson passed away on December 4, 2016, she left a generous donation to the Patricia Chapter, Order of the Eastern Star — a member of the Masonic body. Anne served as a member of the Eastern Star for more than 50 years and provided tremendous support during that time. The Patricia Chapter was not expecting this donation upon her passing and held a special meeting to unanimously decide where to invest and meaningfully donate the gift she left. One of the decisions to come out of that meeting was the idea to invest in a child's future within her community, as Anne had a profound fondness of children.

"Although she did not have children, she often spoke of children because she loved children," shared Pamela Eagleton, Patricia Chapter Trustee.

The chapter established the Anne Simpson Memorial Scholarship at Westwood Collegiate based on a donation of \$10,000 to the St. James Scholarship Foundation. The Foundation, in partnership with the Winnipeg Foundation, is now able to offer this scholarship in perpetuity in the amount of \$500. The scholarship will be presented each year to a deserving candidate based on criteria reflecting Anne's life and values. The successful recipient will have the highest average out of two Grade 12 Science courses, a minimum of 40 community service hours and will be registered to pursue science at the post-secondary level.

The science component of the scholarship seemed a natural fit for an award honouring a woman who spent her life working in the healthcare industry. Anne came to Canada from Scotland with all of her requirements to work as a nurse. She worked at the Health Sciences Centre in Winnipeg as the Supervisor of Nursing where she demonstrated her passion for helping others on a daily basis.

"We felt she would like to help someone going into the health field," said Pamela. "If this donation helps somebody make a decision to go into a program that is science related, then we've won."

The Patricia Chapter recognizes the difficulties placed on young people today and the fact that financial strain may impact a person's decision to pursue further education. While the chapter supports multiple charitable causes in Winnipeg each year, the main criteria of their



donations is to help people.

"We want to confirm to this young person that somebody else has faith in them, a whole organization has faith in them and their process." said Pamela.

The Anne Simpson Memorial Scholarship honours an intelligent, hard-working woman determined to make the most out of life and aims to help future recipients do the same. Anne's peers at the chapter affectionately reminsce about her ability to lighten any room many, many candle power, always match her purse with her shoes, show up with a twinkle in her eye and a smile on her face. According to them, she had an enviable sense of humour and savoir-faire.

The Anne Simpson Memorial Scholarship will be presented for the first time at the Westwood Collegiate graduation on June 25, 2019. Thank you to the Patricia Chapter, Order of the Eastern Star and to the late Anne Simpson on helping to install this new opportunity for deserving youth in our community.

Our History

The history of the St. James Scholarship Foundation is a little like the history of St. James itself, a story of citizens getting together for the advancement of a common cause.

Founded in 1938 and incorporated by the act of the legislature in 1958, the St. James Scholarship Foundation has fulfilled a vital function for many years administering thousands of dollars in scholarships and awards to deserving students in St. James-Assiniboia School Division.

The Foundation began with nothing— no funds and no organization beyond a group of 12 dedicated volunteers. Six months after the inception of the Foundation in December of 1938, the group received its first contribution of \$3.00 raised by the ladies of a bridge group. In the years to come throughout the Second World War, further funds were raised by a group of St. James Collegiate Alumni. The Foundation remained very much a "kitchen table" organization guided by local volunteerism for the next twenty years.

It wasn't until 1958 when a more formal organization was suggested. An interested and passionate group petitioned the Manitoba Government to incorporate the St. James Scholarship Foundation. The petitioners included:

The St. James Scholarship Foundation Incorporation Act came into effect April 9,1958. This began an era of more formal organization and a closer linkage with the administration of the school division, as well as the finance department. The fund benefited greatly from this linkage as members of the finance department began to take on the role of Secretary Treasurer on the board. This significant expertise and experience helped best manage the Foundation's resources. During this period, donated capital was invested into guaranteed investment certificates (GIC) at banks and credit unions. The GIC provided safety for our capital and with historical high interest rates, income could endow an award in perpetuity.

Over time prevailing interest rates began to change and could no longer generate the income needed for the scale of the awards program. This resulted in some underfunded awards being discontinued. With no end in sight and the decline of interest income, the Foundation decided to take a new direction rather than reduce the program. In 2014, an agency fund was established at The Winnipeg Foundation. The fund was initially established with a transfer of \$20,000 from our capital, which was matched with \$15,000 from The Winnipeg Foundation.

In a relatively short period of time, the agency fund has grown substantially. In four years, the fund now stands at over \$140,000. The income produced has allowed for expansion in our program, such as in 2017, the Indigenous Leadership Award was introduced on an annual basis in the amount of \$1000.

The agency fund continues to be of great benefit to donors. It works to enable perpetual awards and can accept donations in many forms as opposed to strictly cash. Donated funds now benefit from professional money management services provided by The Winnipeg Foundation producing income that more than doubles our GIC investments.

During this time the Foundation also developed a web presence on the St. James-Assiniboia School Division website. This enables interested members of the public to review our governance procedures, our meeting minutes and our annual reports. This access to information has been important in encouraging new donations.

The St. James Scholarship Foundation, partnered with The Winnipeg Foundation now sees a future of sustainability and growth. Our new partnership continues to attract new donors, both private and corporate, to continue to benefit deserving students in our community schools. The St. James Scholarship Foundation is a registered charity and all donations are tax deductible. As we reflect on our 80 years in the community, we look forward to continuing to grow our scholarships and awards to best support youth in accomplishing their dreams in St. James-Assiniboia.

How to Donate

How to Donate

The St. James Scholarship Foundation serves our award recipients and our donors by maintaining two endowment funds. These are funds on deposit with local financial institutions and our Agency Fund at the Winnipeg Foundation.

Prospective donors may choose to fund a new scholarship or alternatively, they may prefer to donate to the pooled fund in one of our two endowment funds. Prospective donors wishing to establish a new award are advised to contact the school principal at the chosen school to complete the application form required by the school division. Principals are able to give good advice on possible award criteria as they are very well aware of the needs of their students and their awards program. Locally Endowed Awards

Funds held in our local endowment are managed using GIC's at prevailing interest rates. Interest rates have been at historic low levels recently and for this reason they do not permit perpetual endowment of awards. Prospective donors are advised that our local endowment can support an award for a term of years. As an example, a donation of \$2500 would support a \$250 annual award for approximately ten years. Donors may also choose to contribute to our general pool of funds and in this way provide a more general benefit to our fund.

Winnipeg Foundation Agency Fund Endowed Awards

Prospective donors wishing to endow an award in perpetuity are able, through us, to establish a sub-fund within our Agency Fund. These donations must be a minimum of \$10,000 to be accepted by the Winnipeg Foundation. They also benefit from the dollar matching program at the Winnipeg Foundation. Because the Winnipeg Foundation employs a staff of professional money managers they can accept donations in a variety of forms such as investments, as well as cash. Again, to establish an award of this type prospective donors should first contact the school principal or the St. James Scholarship Foundation for advice. Prospective donors wishing to contribute to our pooled funds at the Winnipeg Foundation can make their donation directly to the Winnipeg Foundation referencing the St James Scholarship Foundation Agency Fund.
