  - using Divisional IT Infrastructure without permission for commercial or profit reasons, including advertising products,
  - loading, downloading, or running any software programs or services onto Division computers or onto the Division network without permission from the Technology Department
  - loading, downloading, or running any software programs or services onto any external or portable device without permission from the Technology Department.
