Permit Conditions for the use of School Grounds

- Payment must be by cash or cheque to the St. James-Assiniboia School Division. Payment is due in full once a permit has been approved by the Division.
- 2. The user must not use natural turf areas during inclement weather and when excessive moisture content of the turf could cause damage to the grounds. The decision to play or not will be left to the discretion of the user for a common sense decision. If any of the following conditions occur, scheduled games, practices and events must be canceled or postponed:
 - The existence of rain on game or practice day which could cause injury to participants or damage to fields.
 - Water surfacing or bubbling up when walking on turf.
 - Field is muddy to the point that footing becomes unstable (players slipping and sliding).
 - Standing water on the field.
 - 24 mm or more of rain 48 hours prior to scheduled game or practice accompanied by rain on the event day.
 - Extreme drought conditions where 50% of the playing surface has turned dormant.
 - Audible thunder or visible lightning.
 - Frost or snow.
 - Sharp or other dangerous objects on field (i.e. broken glass, large unmovable rocks, broken base pegs, holes, etc.)

If damage occurs as a result of user decision to play, the permit holder will be held responsible for all repair costs and may also have their permit privileges revoked.

3. The user must maintain and keep in force during the term of the permit agreement a general liability insurance policy in respect of the grounds or parties thereof named in the permit agreement with minimum limits of \$500,000. The Division must be included as an additional name insured. At the Division's request, a certified copy of the policy or a certificate of insurance must be filed prior to commencement of use.

- 4. The grounds are to be used on the date or dates and for the purpose specified.
- 5. The grounds must be vacated at the time the permit expires each day.
- 6. Permits are not transferable.
- 7. Liquor is not allowed on the premises.
- 8. Smoking is not allowed on the premises.
- 9. No advertising is allowed on the grounds without the prior written consent of the Superintendent/CEO or designate.
- 10. Immediately following the use of the grounds, all paper and garbage must be removed from the athletic field.
- 11. Vehicles must not be driven or parked on the playing surface or any grassed area.
- 12. All permit use must be of a high moral standard.
- 13. The user must carry their field permit at all times to ensure guaranteed use of the field.
- 14. Any group found not following these guidelines may have their permit cancelled.
- 15. The School Division reserves the right to cancel any permit.

Refunds

There is no cash compensation for rain dates. Those leagues wishing to reschedule games cancelled because of inclement weather can contact the Division's Permit Clerk and an effort will be made to provide makeup dates on available fields during July and August.
