To carry out all other performance responsibilities as defined in the Psychologist job description.

- 5 years of successful experience preferably working in Early, Middle, and Senior Years

- Knowledge of provincial legislation and regulations pertaining to clinical services and public education
- Demonstrated effective leadership of teams
- Successful experience in mentoring new clinicians
- Effective assessment and programming skills (academic and behavioural) experienced in a variety of educational settings
- Effective critical incident response, Risk Assessment/Intervention, Suicide Safety Planning skills
- Demonstrated ability with data-informed decision-making
- Ability to work effectively with Divisional and school employees, parents, students, corporate and government partners, and community members
- Ability to work collaboratively with Senior Administration, Division Staff, and multi-disciplinary school teams to address barriers to learning faced by students and families

 - Assessing the clinical skills of permanently certified clinicians as part of the performance appraisal process including recommendations for any professional development of staff.
 - Assessing the clinical skills of provisionally certified clinicians to identify requirements for permanent certification.
 - Providing mentorship to new clinicians.
- Providing leadership for programming and services to support students and their families in the contexts of school, home, and community environments.
- Providing supervision to clinical staff as required for Professional Certification and Professional associations.
- Monitoring and supporting professional practice
- Maintaining professional relationships and liaison with Manitoba Education and Early Childhood Learning – Professional Certification and Manitoba Association of School Psychologists
- Providing leadership for the on-going development and promotion of Division and Educational Support Services priorities.
- Ensuring the creation and delivery of divisional and/or school-based professional development opportunities are aligned with divisional priorities.
- Providing leadership to Clinicians, ensuring alignment with the Division Mission, Vision and Values including the Service Delivery model.
- Providing leadership and oversight to divisional initiatives, such as the Risk Assessment/Intervention, Responding to Sexual Assault protocol and 8-Step Suicidal Ideation process.
