SUPERVISION OF STUDENTS AT LUNCH HOUR

It is the policy of the St. James-Assiniboia School Division that students should go home for lunch unless this is not feasible for reasons of distance, severe weather, health problems or physical disabilities. Students who attend schools in St. James Assiniboia are eligible to stay at school for lunch.

Eligibility for Lunch Privileges: K to Grade 12

All K to Grade 12 students enrolled in a school on a full-day basis are eligible to have their lunch at school throughout the year.

For all students who have lunch at school, supervision is required in the lunchroom and on the playground after the lunch period. The responsibility for this supervision rests with the school principal and staff. The school has the authority to suspend a student's lunch privilege if the conduct of the student contravenes the school's Code of Conduct.

LUNCH PROGRAM SUPERVISORS FOR GRADES K TO 5:

Early years schools are entitled to hire adult lunch program supervisors according to the table below:
