3. Technology Discussion: Rob Carnegie, Administrator of Technology

Rob Carnegie, Administrator of Technology, provided an update regarding technology. Topics included school division and school websites, division portal, social media usage, classroom blogs and electronic communication with parents. In addition, Mr. Carnegie highlighted March Break as the target date for the Division to move off First Class to the new system. The Committee had an opportunity to ask questions and provide comments.

4. Additional Funding Requests (2018-2019) Preliminary Discussion

Administration provided additional funding request recommendations for consideration in the 20180/2019 Budget. The Committee discussed the items and will now consider the full proposals at the Pre-Budget meeting on January 17th, 2018.

5. InformNet Year End Report 2016-2017 Motion 19-12-17

Administration provided the annual InformNet report, which includes a financial component. Course completion rates continue to increase. Priority for student applications goes to both Pembina Trails School Division and St. James-Assiniboia School Division, as these two divisions are partners in InformNet.

6. Compiled Parent Trustee Forum Responses Motion 19-15-17

Responses from the November 18, 2017 Parent Trustee Forum were compiled and shared with the Committee. Administration shared the compilation with school administrators at an upcoming Administrative Council meeting. Based on the responses Administrators will create a set of FAQs, which will address parent input. Once developed the FAQs will be presented at a future Education Committee meeting. Responses from the Forum will also be posted on the Division website.

Trustee Hume provided a summary of a recent professional development session, which focused on sharing positive stories with the public.
