DISCUSSION AND RECOMMENDATIONS

1. Call to Order / Attendance

Trustee Bruce Chegus called the meeting to order at 5:07 p.m.

4. Trustee PD Summaries

Trustee Lawson presented information received on The Key Work of School Boards (Guidebook) at the National School Board Association Annual Conference in San Antonio 2018.

The Guidebook contains five chapters: Vision, Accountability, Policy, Community Leadership, and Board and Superintendent Relationships. The appendix lists the Eight Characteristics of Effective School Boards.

INFORMATION ITEMS – AGENDA ITEMS 4 – 11

a) Indigenous Education Aboriginal Academic Achievement (AAA) Grant Year-End Report 2017-2018 Motion 16-26-18

Administration presented the annual report on Indigenous Education in SJASD for 2017-2018. The planning process this past year consisted of data conversations with the Indigenous team comprised of two Indigenous Education teachers, one Indigenous Student Success Coach, four educational assistants, as well as educators from various levels (curriculum and student services coordinators, superintendents, school administrators, and the EAL Team). These data conversations were then aligned with the goals identified in the AAA Grant and our Indigenous PATH (2016):

- To increase academic achievement
- To provide targeted literacy and numeracy interventions
- To increase the graduation rates of Indigenous students in all five senior years schools
- To increase understanding of the Indigenous worldview and perspectives

These goals provided direction for intentional learning, expected outcomes, indicators, strategies, data collection, and allocation of resources, programming and supports for Indigenous Education during the 2017-2018 school year.

b) Family Access Program Year End Report 2017-2018 Motion 16-27-18

The Family Access Program provides resources and supports to assist students with staying in school and achieving academic success. The program promotes healthy outcomes for students and families through the provision of a variety of supports.

During the 2017-2018 school year, the Family Access Program worked with a total of 157 students (120 families) from 20 schools, ranging from Kindergarten to Grade nine. There were 93 Indigenous students involved in the program, comprising 59% of the caseload. Interested students were connected to Indigenous programming within their schools and many caregivers were referred to culturally relevant services. There were 18 students identified as EAL learners in the program (12% of caseload) and the Family Access social worker consulted regularly with the EAL support teachers.

The Family Access Program a.) provides students and families day-to-day practical strategies and support, referrals to and/or assistance accessing community agencies, b.) builds and maintains positive relationships with identified students and their families by meeting them in their home, school or community to develop a plan to increase attendance, and c.) collaborates with the Learning to Age 18 Support Teacher and other agencies to ensure that students remain engaged in the school system.

In 2017-2018, attendance improved or stabilized for 96 students.

c) Behaviour Intervention Team Annual Report June 2018 Motion 16-28-18

The Behaviour Intervention Team provides support to students from Kindergarten to Grade 8 with complex behaviour issues and consultation to the senior years is provided. The Behaviour Team is comprised of the equivalent of two full time Behaviour Intervention Resource teachers and seven full- time Behaviour Intervention assistants and provides professional development to staff in order to build capacity for meeting the diverse needs of students.

During the 2017-2018 school year, 170 students received support. 64% of students open to the Behaviour Team are early years, 28% middle years, and 8% senior years. Support also included 26 class-wide interventions (Zones of Regulations, Roots of Empathy, How Does Your Engine Run, social skills projects, cognitive behaviour therapy, classroom management), one eight-week parent group, and fifteen family and classroom presentations.

d) Learning to Age 18 Support Teacher Final Report June 2018 Motion 16-29-18

The Learning to Age 18 Support Teacher worked with 103 identified students in the 2017-2018 school year. In consultation with the senior years schools, alternative planning for students was put in place. The LTA18 Teacher collaborates with the Family Access facilitator and the Career Development and Placement teacher to aid in student success.

e) Protocol for Initial Intake and Assessment of EAL & LAL Students Grade K-12 Motion 16-30-18

Three protocols have been developed (K-4, 5-8, 9-12) and are being implemented this year. The protocol contains an initial interview for parents and an initial assessment tool for students to better understand their English language and Math learning needs.

f) Reading Recovery Report 2017-2018 Motion 17-19-18

The annual Reading Recovery Report provides information on student progress, an overview of Reading Recovery and highlights on recommendations. Reading Recovery has been the early literacy intervention choice since 1994-95. In 2017-2018, 16 RR teachers and four teachers in training delivered individual lessons to 152 students.
