9. Discovery Children's Centre Update

The Committee received an update on lease negotiations with Discovery Children's Centre. Discussion focused on breakeven costs for the Britannia building as well as significant upcoming projects.

Administration is currently awaiting correspondence from PSFB regarding funding for major projects at surplus buildings as well as legal counsel regarding the current lease rates.

The Committee was advised that negotiations with Discovery will resume in March 2020.

10. Fairlane Children's Centre Leasehold Improvement Request

The Committee reviewed a request from Fairlane Children's Centre to undertake leasehold improvements, including floor upgrades, painting and reconfiguration of room 106 in their leased space at Hedges Middle School.

That the leasehold improvement request from Fairlane Children's Centre be approved.
