# 1. Call to Order/Attendance

# 2. Approval of Agenda

# 3. Staff Appreciation

The Committee discussed options for spending money available from this year's Trustee PD Fund including sending a per employee amount to each school as well as the possibility of a mural celebrating diversity and inclusion on the outside of the Board Office.

# 4. GCBBA Excluded Staff Compensation and Benefits

# 5. MANTE Job Description

# 6. MANTE Casual Rates

Administration requested that support staff casual rates receive increases consistent with the recent MANTE collective agreement settlement effective July 1, 2021 and July 1, 2022.

# The Personnel Committee recommends:

That the casual rates be increased as requested.

# 7. Casual/Substitute Sign-Off Sheet re: Covid

Administration shared the idea that we permit a one-time exemption on the need to re-do child abuse and criminal record checks for casual/substitute employees that have worked consecutively for five years and/or who were previously retired from the Division if they did not work this year due to Covid.

The Committee instead suggested that this same group of employees be required to re-do their checks, but that the Division pay the cost of the checks.

#### The Personnel Committee recommends:

The Division pay the cost to re-do child abuse and criminal record checks for casual/substitute employees who are either previously retired from the Division or who have five years of service if they wish to work again next year.

# 8. Vaccination Policy Discussion Paper

The Committee discussed a Canadian legal paper regarding mandatory vaccination policies.
