3. French Immersion Parent Opportunities to Attend Basic French – Information Motion 11-21-19

Manitoba Parents for French promotes French learning for FASL parents, specifically for Parent Councils. A variety of other supports are included with a membership. Trustee Glennie will meet with Manitoba Parents for French to gather further information.

The list of flags and timelines was discussed.

b) Continuing Education Program/International Student Program Reports Motion 15-11-19

Assistant Superintendent Wake reviewed the reports from Continuing Education and International Student Programs. The reports indicate that both programs continue to be successful in the Division.

In 2018-2019, there were 125 certificate program graduates from Continuing Education. The Continuing Education administration continues to explore certificate and general interest programs that meet the needs of the community. There was an increase in the number of new Canadians studying in the program and, as a result, administration is working with provincial and federal government agencies, instructors and the community to meet the needs of students.

The International Student Program (ISP) hosted 163 students in 2018-2019. Administration continues to explore various markets to enhance the learning experiences of students. ISP students experience strong support from ISP staff, school staff and community/homestays. All international students received the necessary English language support and appropriate academic planning. As of June 2019, six graduates of the program planned to attend U of M and another seven to attend universities across Canada.

c) InformNet Year End Report 2018-2019 Motion 15-12-19

Assistant Superintendent Wake presented the InformNet report 2018-2019. InformNet is an accredited online high school where currently 300 students participate in internet-based learning experiences. SJASD and Pembina Trails each receive 10 seats per course; Winnipeg School Division has doubled their seats from 17-18 to 60 in total. The InformNet principal is building strong relationships with the students' guidance teams and school administration, to share ongoing student progress, discussions about student placements and collaborative problem solving – ensuring students log in, continue to hand in work and finish assessments.

InformNet allows students to use their own ideas and produce honest work in order to earn credits. Students, parents and schools are provided with a monthly progress report. InformNet also offers summer school at a fee to all school divisions in the province.
