École Bannatyne - Building Positive Relationships

Presented By: Roné Boyko, Principal, Jennifer Rothwell, Vice Principal, Katie Hindle, Kindergarten Teacher and students

The main concept of the presentation by École Bannatyne was to highlight the importance of building positive relationships within the culture of a classroom and within the school. Two students spoke about their time in kindergarten and how their classroom teacher was instrumental in making them feel safe. They both reflected on their years at École Bannatyne as they move on to middle years next. A third student from the kindergarten class was in attendance with her parent who spoke about the importance of a positive relationship between the teacher and student in order to build trust. Trustees watched a video of middle and senior years students who were asked to reflect on a past teacher from École Bannatyne who was memorable to each of them. The presentation concluded with the following statement by Madame Hindle, 'When we nurture the relationships in our classrooms, magic happens'.
