Sources of Strength is a student led suicide prevention program that uses fun school-wide activities to highlight eight areas of strength to build resiliency and healthy coping. Sources of Strength relies on the power of peer networking to spread the word that it is okay to need help sometimes and there are caring adults that youth can turn to for help and support.

The goal is to run the program in all the middle and high schools. Peer training is now being offered to make this happen and they are looking at facilitating in some of the early years schools as well. The SOS program usually melds well with activities the schools are already doing.
