# **Educational Support Services – Project 11**

# Presented by: Suzi Friesen, Director of Educational Programming, True North Youth Foundation (TNYF)

Project 11 is an engaging cross-curricular proactive mental wellness program that targets Manitoba's Health Education and Language Arts outcomes for students.

Project 11 is created in honour of #11, Rick Rypien, a former player of the Winnipeg Jets and Manitoba Moose. With dedicated support from the Winnipeg Jets and Manitoba Moose, the True North Youth Foundation began developing Project 11 in 2012. The first phase focused on the development of a middle years program (grades 5-8 in English) and was followed by the development of the early years program (grades K-4 in both English and French).

Project 11 has been busy throughout the pandemic launching the French middle years curriculum, piloting senior years curriculum, and growing teacher training opportunities. In this presentation, TNYF highlighted their work with SJASD teachers and students, along with some highlights from the Winnipeg Jets virtual player visits with SJASD students.

To date, 322 SJASD staff members have accounts to access Project 11 curriculum. This includes all grades from Kindergarten to Grade 8 in both English and French Immersion. It is a 15-week program divided into three sessions.

Themes, Intermission Video areas, and Youth Summits are just part of Project 11 that were touched on in this presentation and data highlights were reviewed. The website at <a href="https://www.projecteleven.ca">https://www.projecteleven.ca</a> was introduced and provides resources, FAQs and curriculum links.
