### **REMOTE LEARNING - A DAY IN THE LIFE**

Remote Learning began in SJASD for the medially advised in October 2020 and then the Temporary Remote school was established in November 2020. Both schools will continue until the end of June 2021.

Principal Henrietta Hoch introduced some of the teachers that are teaching SJASD medically advised remote learners and the temporary remote learners.

Teachers have been planning for their remote learners using the grade level essential outcomes and common assessments in Literacy and Numeracy. Science and Social Studies have been integrated into the Literacy and Numeracy lessons. Some of the activities and platforms used were shared as well as examples of interactions with the students and the parents.
