Continuous Improvement Plan 2019-20

Presented By: Julie Cordova, Administrator of Assessment and Evaluation / School and Community Support & Mike Wake, Assistant Superintendent, Education (K-12) and Administration

Julie Cordova, Administrator of Assessment and Evaluation and Mike Wake, Assistant Superintendent presented the Continuous Improvement Plans for the 2019-2020 school year to the Board of Trustees. The Instructional Support Model and Intensive Learning Days, two of the four areas of continuous improvement work, were the focus of the presentation. Teachers were encouraged to apply for literacy or numeracy coaching support for the 2019-2020 school year by completing an online application form and making a commitment to each of the intensive learning days as well as co-planned days through their coaching partnership. There is also the expectation for these teachers to share and celebrate their learning with their own school teams. Two cohorts of teachers will be supported in the first year of implementation. Up to 90 teachers will participate in the first round from September 2019 to December 2019 and an additional 90 teachers will be supported in the second round. The second round of teachers will be committed to one full year, from January 2020 to December 2020. The cycle will then repeat with new applicants.
