We are committed to honour and learn about the true history of this place, and to do our part to move our community forward in a true spirit of justice and reconciliation.

### AGENDA-BASED QUESTIONS FROM THE PUBLIC

- 1. Pierre Attallah, Community Resident, asked when By-Law 329-23 would be available publicly.
  - Holly Hunter, Board Chair, responded that it would be available in the policy manual on the website in the days following the meeting.

  - Jenness Moffatt, Superintendent, advised that the policy had not been updated since 1996 at which time there used to be an optional lunch program with a fee payment rendered to the school's parent council. This has since changed because SJASD now employs lunch supervisors and supports all pupils to stay for lunch at no charge. As this was no longer a relevant portion of business for parent councils, it was removed from the policy.
- 7. Pierre Attallah, Community Resident, asked if the current policy still stands what allows administration to make changes before the policy has been updated by the Board.

Holly Hunter, Board Chair, advised that Mr. Attallah was no longer asking agendabased questions and the matter would be best addressed in a meeting with Jenness Moffatt, Superintendent.
