The Peaceful Village works with new comer youth Grade 7-12 students and their family members, which is facilitated by Manitoba School Improvement Program (MSIP). Program facilitators work with educators and partner with community members to discuss and then act on the most important issues facing young people and their families. They currently have approximately 675 student located at 5 sites. Students from Fort Richmond Collegiate who participate in the Peaceful Village presented their personal highlights and the value of the program for them. In addition, the program also offers summer, winter and spring break programs along with student exchange programs within Canada.

The program has seen an increase in literacy and numeracy this past year, a number of scholarships were awarded, and the graduation rate of 96% was noted.

This initiative will be reviewed through the 2018-2019 division budget process.
