## École Bannatyne - Data Process to Drive Instruction & Improve Learning

**Presented by:** R. Boyko, Principal and Teachers L. Tanner, D. Wiebe, K. Schmidt and two Grade 3 students.

The presentation highlighted the Got Data process that has been implemented for grades K-5 with a total of 315 students. The project was designed and implemented based on data driven improved best practice in order to improve student engagement and learning. École Bannatyne has been analyzing data to drive improved instruction to ultimately benefit student learning for the past four years. Last year, the process of analyzing data was improved as staff incorporated the Got Data process. School goals have been developed based on improved data analysis and evidence of growth in student learning.
