Winnipeg Jets Hockey Academy - True North Foundation

Presented by: Dwayne Green, Murray Cobb, Corey Coker from the Winnipeg Jets True North Foundation as well as input from Leah Jones, Vice-Principal, Hedges Junior High, Tara Starr, Parent and S. Yousofy, Student.

This presentation focused on the Winnipeg Jets Hockey Academy (WJHA) and its main concept which is to help students create an attachment to their academic lives and a connection to their school. This is done through providing students weekly onice sessions during the school day and weekly after school sessions. The program also offers additional academic supports to at the high school level. Additionally, many field trips and social opportunities are presented.

In the St. James-Assiniboia School Division, the program is available in 5 elementary schools, 4 middle schools and all high schools. The program begins as early as Grade 2 and follows the students until high school graduation. In total 425 students take part in the WJHA in our Division.
