The presentation provided an update in respect to the Aboriginal Academic Achievement Team. The data provided highlighted the outcomes of the program to date as well as the ongoing challenges that the program continues to work with. Currently the Division has seen improved graduation rates and increased academic achievement. This has been achieved through tiered interventions for students struggling with literacy and an increased connection of Indigenous students and their families and schools. Professional development has led to increased awareness for schools and staff in the areas of The Talking Circle, Indigenous Ways of Knowing, Treaties, The Tipi, Residential Schools and Truth and Reconciliation.

Indigenous Education will continue to flourish and expand in our Division. Future resources and supports will address Indigenous students struggling with literacy and numeracy, and improving graduation rates.
