John Taylor Collegiate - How Technology assists with our Numeracy Education Program Presented by: Staff: Scott Lockhart, Principal, Kari Bergmuller, Math Department Head, Keith Goetz, Math Teacher Students: Colby and Taylor

This presentation highlighted the engaging activities that make a significant difference in the learning of students. Some examples are vertical thinking spaces, hands on construction, co-teaching, interactive games, video projects, iPad activities and a new math resource program (conditioning math). Technology tools such as Edmodo assist students who may need to be away from the class for sickness, vacation or various reasons, while still allowing them to keep up to date. Additionally, if a specifically tough topic arises, Edmodo can be used to review material (in video form) prior to upcoming tests. Students are enjoying math, sometimes for the first time ever.
