-Goal of the Crestview Parent Council over the years has been to build a new play structure Cost would be \$100,000. Background of play structure renewal project was shared, spanning over 10 years. Initial plan was to have a natural play area, this was changed due to the cost and sustainability of such a project considering the school grounds baseball diamonds are used by the community. Roadblocks have been

fundraising during a Pandemic, and the need to form a committee to work on writing and applying for outside grants. On site Crestview Children's center will partner with Crestview School as we share the play area.

5. New business: Motion made to hold contribution to Grade 5 Farewell Funds for this year. To resume annual contribution in June 2023. Historically the Parent Council has contributed approx. \$250. to enhance grade 5 Farewell event in the form of refreshments. All agreed.
