#### Approval of Agenda and Minutes

S. McClelland tabled the meeting agenda. K. McMillan made the motion to have the agenda accepted and the motion was seconded by N. Schneider. All agreed and the motion was carried.

The minutes from the October 23, 2020 AGM were read. K. Jenkinson made a motion to have the minutes accepted and the motion was seconded by J. Dyson. All agreed and the motion was carried.

#### **Executive Reports**

#### 1. Principal's Report:

A. Tyler presented her report. S. McClelland made the motion to have the report accepted and the motion was seconded by P. Creary. All agreed and the motion was carried.

#### Key points:

- Enrollment remains at 254; this figure includes remote learners.
- Free lunch program parents were reminded of lunch program expectations for students.
- School team name and logo students are involved in classroom discussions about a new team name and logo. The school is interested in finding agreement on a name that is as inclusive as possible; currently looking into names in line with animals.
- School fundraiser school is looking at options for fundraising in the spring. Much of what happens will be dictated by pandemic guidelines at that point. The objective of that fundraiser is to deliver books to students' hands.
- S. McClelland made the motion to have the Principal's report accepted and the motion was seconded by P. Creary. All agreed and the motion was carried.

#### 2. President's Report:

S. McClelland reported that he had reviewed the constitution and had created the ÉVPC email account: <a href="mailto:evparentcouncil@gmail.com">evparentcouncil@gmail.com</a>. The account is used for ÉVPC business and parents can reach any member of the executive at this address. K. Jenkinson made a motion to have the President's report accepted and J. Dyson seconded the motion. All agreed and the motion was carried.

#### 3. Treasurer's Report:

N. Schneider presented her report.

#### Key points:

- The latest report shows a corrected balance of \$5349.06. The correction came after it was noticed that two cheques totaling (\$1771.05) had been erroneously included in the 2019-2020 yearend balance.
- It was confirmed that \$2500 (\$500 more than the minimum amount mandated by the SJASD) will be held in reserve for 2020-2021.
- After discussing the fundraising and spending proposals outlined in the report, the meeting agreed to the following:
  - The ÉVPC will forego this year's Christmas Craft activity and allocate \$1950.00 to classroom supplies. This would allow each classroom to have \$150 for additional 'indoor recess' items as determined by the teachers.
  - o \$500 will be set aside for the Grade 5 Farewell.
  - o Committees will be set up to examine fundraising options.
- Following the discussion J. Dyson made a motion to have the report accepted and the motion
  was seconded by K. Jenkinson. The motion was carried. A copy of the revised and accepted
  report is attached to the minutes.

### Committee Reports

#### Social Media Report:

C. Yaholkoski reported that the Instagram page for the ÉVPC is now set up. A Facebook page will be added soon.

#### **New Business**

The meeting agreed that the following two committees could be established now and that other committees might follow in the 2021 or as COVID-19 restrictions evolve.

- 1. Virtual Bookfair Fundraiser: N. Schneider suggested holding a Virtual Bookfair. S. McClelland will assist in investigating and planning this activity.
- 2. Grade 5 Farewell Committee: C. Yaholkoski, J. Hughes, S. Schatz, and P. Creary will form the committee.

A motion to adjourn was made by J. Dyson at 7.16 PM and seconded by K. Jenkinson. The motion was unanimously carried.
