**CSHC Safe Grad Rules**

1. Admission to the Safe Grad functions will be limited to graduates and one invited guest per grad. Supervisors at the door will have a list of graduates and guests. No one will be allowed in without their name being on the master list. Drop off starts at : 10:30 pm and all attendees must be checked in by 11:30 pm. **Parents/guardians must come into The RBC Convention centre to sign in their grad/guest.**
2. Any attendee who is found with “ contraband” items will be required to leave the premises. **There will be no exceptions.**
3. **No cell phones, bags, cameras, vrd, backpacks or coats** are permitted in the Safe Grad Venues.
4. **Proof of age** is required by all graduates and guests attending on June 27<sup>th</sup>, 2024. Accepted forms of identification are Manitoba Driver’s License, a Manitoba enhanced Identification Card or Canadian Passport. **These are the only forms of I.D. accepted, Period!**
5. Grads and guests that are 18 years and older will be identified with a special wristband upon entrance. Only persons with this wristband may purchase or drink alcohol. Bartenders will not serve more than two drinks per quest, per visit to the bar. It is a cash bar.
6. In compliance with the Liquor Control Act, any attendee who is judged to have had too much to drink will be refused service and will have their alcohol confiscated and their wrist band removed.
7. There will be no access to an ATM during the safe grad event- **There will be no exceptions.**
8. Non- Alcoholic drinks and food will be available.
9. Grads are responsible for **their own** and **their guest’s** behaviour. **IF the grad leaves, his/her guest must also leave;** but if the guest leaves the grad will not have to leave
10. Anyone involved in a fight or any other aggressive physical contact, either as an instigator or retaliator, will be taken home by their parent/ parental designate with “ no questions asked”.
11. There will be **no smoking or vaping** at this event, There will be no alcohol allowed outside the venue.
12. The Bar will close at 2:00 am, non –alcoholic beverages will be served until 2:30 am.
13. **All grads and guests must be picked up by 3:00 am.**
14. Everyone, regardless of how much he/she has had to drink, will be picked up by his/her parents/parental designate. If a grad or guest wishes to leave early, parents/parental designates will be notified to pick them up. **Anyone who leaves will not be allowed to return.**
15. The parent/designated driver must come inside The RBC Convention Centre to sign out their Grad/Guest. **ONLY parents/parent designates that are listed on the consent and transportation form will be allowed to sign out their grad/guest. Identification must be presented to pick up grad/guest.**
